

CROATIAN PSYCHOLOGICAL CHAMBER

Pursuant to Articles 27 and 32 of the Act on Psychological Activity ("Official Gazette", Nos. 98/79 and 18/22) and Article 41 of the Statute of the Croatian Psychological Chamber ("Official Gazette", Nos. 21/21, 109/22), the Assembly of the Croatian Psychological Chamber, at its 7th session held from 20 to 21 February 2026, with the prior consent of the ministry responsible for social welfare, Class: 550-06/26-01, Reg. No.: 524-09-01-03/2-26-3 of 19 January 2026, adopts:

AMENDMENTS

TO THE STATUTE OF THE CROATIAN PSYCHOLOGICAL
CHAMBER

Article 1

(1) In the Statute of the Croatian Psychological Chamber ("Official Gazette", Nos. 21/21, 109/22), in Article 4, after paragraph 1, a new paragraph 2 is added:

"(2) The abbreviated name of the Chamber is: HPK."

(2) Former paragraphs 2 and 3 become paragraphs 3 and 4.

(3) After paragraph 4, a new paragraph 5 is added:

"(5) The official website of the Chamber is: www.psiholoska-komora.hr."

Article 2

(1) In Article 5, paragraph 1 is amended:

"(1) The emblem of the Chamber is circular in shape and consists of two head profiles facing left and right, with the Greek letter 'Ψ' between them."

(2) Paragraph 2 is deleted.

(3) Former paragraphs 3 and 4 become paragraphs 2 and 3.

(4) Paragraph 3 is amended:

“(3) Based on the approval of the ministry responsible for public administration, the Chamber uses a seal bearing the coat of arms of the Republic of Croatia on documents issued within its public authority. The seal is circular, 38 mm in diameter, with the following text on the edge: ‘REPUBLIC OF CROATIA - CROATIAN PSYCHOLOGICAL CHAMBER’, the number of issued seals, and the coat of arms of the Republic of Croatia in the center, below which is written: ZAGREB.”

Article 3

Throughout the text of the Statute of the Croatian Psychological Chamber (“Official Gazette”, Nos. 21/21, 109/22), the words “ethical code of psychological activity” in the appropriate case are replaced with “Ethical code of psychological activity” in the corresponding case.

Article 4

In Article 8, paragraph 1, after the words “joint private psychological practice”, a comma and the words “records of issued approvals for the registration of psychological activity” are added.

Article 5

(1) In Article 10, paragraph 8, subparagraph 8 is deleted.

(2) Former subparagraphs 9, 10, 11, 12, and 13 become subparagraphs 8, 9, 10, 11, and 12.

Article 6

In Article 17, paragraph 2, after the words “by a majority vote”, the word “present” is deleted.

Article 7

(1) In Article 19, paragraph 1, after subparagraph 8, a new subparagraph 9 is added: “- adopts acts regulating in more detail the structure, titles and job descriptions, education levels, and other matters relevant for the detailed organization of work and office operations in the Secretariat of the Chamber.”

(2) Former subparagraphs 9, 10, 11, 12, 13, 14, 15, and 16 become subparagraphs 10, 11, 12, 13, 14, 15, 16, and 17.

Article 8

In Article 22, a new paragraph 4 is added:

“(4) The President and Deputy President of the Chamber may perform their duties within their scope of work with or without entering into an employment relationship.”

Article 9

- (1) In Article 27, after subparagraph 5, a new subparagraph 6 is added:
“- adopts guidelines for the application of the Ethical code of psychological activity.”
- (2) Former subparagraph 6 becomes subparagraph 7.

Article 10

- (1) In Article 29, paragraph 2, the word “five” is replaced by “eight”, and the word “three” is replaced by “six”.
- (2) Article 29, paragraph 3 is amended:
“(3) Members of the Court of Honour from among licensed psychologists are elected by members of the Chamber in direct and secret elections for a term of four years.”
- (3) After paragraph 3, a new paragraph 4 is added:
“(4) Members of the Court of Honour from among professional judges are appointed by the Assembly upon proposal of the Management Board for a term of four years.”
- (4) Former paragraphs 4 and 5 become paragraphs 5 and 6.

Article 11

In Article 32, paragraph 1 is amended:
“(1) Financial penalties may be imposed in the amount of EUR 300.00 to EUR 1,000.00 for minor breaches of duties of psychologists, and EUR 1,200.00 to EUR 3,000.00 for serious breaches of duties of psychologist.”

Article 12

In Article 32a, paragraph 2, the words “Members of the Assembly” are replaced by “The Assembly”, and the word “elected” is replaced by “appointed”.

FINAL PROVISION

Article 13

These Amendments to the Statute shall be published in the “Official Gazette” and shall enter into force on the eighth day following their publication in the “Official Gazette”.
